Mississippi State Hospital Psychiatry Residents - Class of 2028

On July 1, the newest class of Psychiatry Residents began clinical duty on the MSH campus. The Psychiatry Residency program is a four-year accredited program that accepts six residents each year. Heading into its fourth year, the arrival of the latest group marks the first time the program will operate at full capacity.

Dr. Jon Jackson, Program Director, shared that this year, the MSH Psychiatry Residency program received over 500 applicants for the six positions available. The team interviewed over 80 applicants, with all six positions matching in the initial round of the National Resident Matching Program. All residents selected are from the south, and three are Mississippi natives.

The main attraction was recognition of individuals who have dedicated their time and resources to enhance the quality of life for our patients and residents.

Mr. Ray Wallace, Friends of MSH President, welcomed a packed room of guests to the meeting, with Mr. Gale Martin, Friends Board Member Emeritus, giving the invocation. Mr. Jessie Buckley, Board Member Emeritus, led the Pledge of Allegiance. Mr. Wallace then recognized Board Members and special guests in attendance. Mr. James G. Chastain took the podium to present the Nancy B. Foreman Award, the Vivian Shivers Award, and the Jerald D. Ball – Together We Make a Difference Award.

The Nancy B. Foreman Award was presented to the Jackson MS Alumnae Chapter of Delta Sigma Theta Sorority, Incorporated. This award was established in appreciation of the dedication and service of Ms. Nancy B. Foreman, who was one of seven people to sign the charter to establish the Friends organization in 1987. She served as President from 1989 to 1993 and remained an active Board member until her death. She traveled throughout the state at her own expense to educate the public about mental illness and served as a tireless advocate for Mississippi State Hospital. She also led grassroots advocacy efforts with the legislature. Ms. Foreman inspired her family, friends, and community and continuously encouraged them to volunteer at MSH. Her daughter, Anne, followed her as President of Friends from 1993 to 1995. This award is given each year to an individual or group who has demonstrated through their service, their commitment to enhancing the quality of life for persons with mental illness.

The Jackson MS Alumnae Chapter of Delta Sigma Theta Sorority, Inc. has been





involved in providing Christmas parties and activities at Mississippi State Hospital for more than 25 years. They currently visit the Continued Treatment Programs in Buildings 45 and 46. Nothing stops these ladies, even during COVID they made sure our patients were not forgotten and arranged special deliveries for them.

Chapter members volunteer at MSH each year because it allows them to impact the families and communities they serve while showing their commitment to one of the sorority's programmatic thrust, which is Physical and Mental Health. For them, volunteering at MSH is a way to make a positive impact on the lives of patients and staff and a chance to give back to the community while gaining valuable insights and contributing to a cause they care about.

Mr. Chastain presented this special award to Ms. Gloria Ball, Physical and Mental Health Committee Chair, and Ms. Nakisha Davis, President. Ms. Davis spoke on behalf of the group and shared, "On behalf of the Jackson Alumnae Chapter of the



452 women I represent today, we would like to give an extreme thank you to the Friends of Mississippi State Hospital. We look forward to continuing the service we do in the community and at Mississippi State Hospital." Ms. Ball added, "We chose Mississippi State Hospital in order to focus on physical and mental health, which is one of our sorority's five-point programmatic thrusts. We visit MSH once a year and enjoy uplifting the ladies receiving treatment, as well as the staff. We are very surprised by this award and look forward to being here in December to support these ladies again."

St. Mark Church was selected as recipient of the Vivian Shivers Award. Formerly the Helping Hands Award, this award was established in 2006 and renamed in 2009 to honor Ms. Vivian Shivers. Ms. Shivers began her career as a Registered Nurse at MSH in 1976 in one of the original tuberculosis wards, and later served in Jaquith Nursing Home. After



her retirement in 1987, she remained an active volunteer and advocate for MSH until her death in 2009. She served as both President and Vice-President of the Friends organization and was active on numerous committees. She routinely attended and volunteered at special patient/resident events and activities. Ms. Shivers was selected as the MSH Volunteer of the Year for the Mississippi Hospital Association in 2001. In addition to her service at MSH, she was a loved and respected member of her community and church in Magee, MS.

This award was established to honor an individual or group who represents the volunteer spirit and sets the standard for future generations. St. Mark Church has been active in volunteering at Mississippi State Hospital for more than 30 years. During that time, they have hosted Christmas parties and activities for hundreds of nursing home residents, most recently in Building 78, which currently



has 45 beds, all males with a wide range of abilities and disabilities. It would be a challenge for any organization but not for St. Mark. They were never more important to our residents than during COVID when direct contact from the outside world, even their families, was restricted or not allowed at all. Through it all, St. Mark continued their Christmas mission by providing for those residents regardless of the pandemic. As soon as volunteers were allowed to come back in 2022, they were one of the first groups to call.

One of the more well-known benefits of volunteering is the impact on the community. Volunteering allows you to connect to your community, help people feel less isolated, and make the world a better place. Even helping out with the smallest tasks can make a real difference to the lives of people and organizations. St. Mark truly makes a difference for Jaquith Nursing Home and Mississippi State Hospital. We are so grateful for their continued support.

Mr. Chastain presented this special award to Ms. Ophelia Kelly, Ms. Emma L. Taylor, and Pastor Willis Washington, Jr. Ms. Kelly, who was one of the original members of the group that began visiting MSH over 30 years ago, shared, "St. Mark looked at the community and decided we wanted to have a ministry that focused on a population that the rest of the world might overlook. recognition. Originally named Together We Make a Difference Award, the name was changed in 2018 to honor Mr. Jerald D. Ball. Mr. Ball began his career at MSH in 1984 when he became the Director of Volunteer Services. He immediately developed a plan to recruit and retain volunteers, provide needed clothing through a donation center, and provide for all patients/residents during the holiday season. He also developed "Santa Day" where business leaders, legislators, and others dressed as Santa Claus to personally deliver the bags to every individual served by the hospital.

Mr. Ball also sowed the seeds for Friends of MSH and was a charter member in 1987. This coming year, Friends will provide more than \$20,000 for projects. After his retirement in 2005, Mr. Ball remained an avid supporter and volunteer at MSH until his death in 2018. His programs will continue to reap dividends for our patients and residents well into the future. Mr. Jerald Ball exemplified the spirit of volunteer service, and spent his professional and personal life promoting and nurturing that spirit in others.

Earlier this year, the Mississippi Museum of Art invited the MSH Art Program to feature a "Sneak Peek" of the 35th Annual Serendipity Art Show & Silent Auction. The Serendipity exhibit opened on Thursday, June 6th, with a special reception for the artists. Artists arrived at the museum and were greeted with an impressive display of their artwork. Each piece was hung and identified by a museum label that included the artist's name, name of the piece, materials of the work, and a quote from the artist.

Wyatt Waters, renowned watercolor artist, and Ron Lindsey, former MSH Art Instructor, made a surprise visit and viewed the entire collection of artwork. After the viewing, the artists gathered in the Community Room of the MMA for refreshments and were presented with a certificate of recognition mounted in a special Serendipity Sneak Peek folder with a photo of their artwork and personal quote printed inside. and Ricky Shelby, MSH Art Instructor. Afterwards, Waters and Lindsey worked their way around the room discussing various art topics with the MSH artists. The MSH Music Department Trio was in attendance and performed during the opening adding a special flair to the event.

The Serendipity Sneak Peek was in conjunction with the Noah Saterstrom show, "What Became of Dr. Smith". It explores the story of Noah's greatgrandfather, a traveling optometrist, who disappeared in 1924. His years-long search yielded evidence of a complex set of events that resulted in Dr. Smith's institutionalization for 40 years at the MS Insane Asylum in Jackson, and later at MSH. Presented as a narrative painting of 183 canvases that together span 122 feet, the exhibit is a visual culmination of the story. The exhibit expands on Saterstrom and the Asylum Hill Projects shared goal of acknowledging those marginalized by society due to mental illness.

The Serendipity Sneak Peek exhibit ran from June 6 until August 12. We are

thankful for Mississippi Museum of Art's support of the MSH Art Program as well as their commitment to mental health awareness.

Ms. Marjorie Ball, widow of Mr. Jerald Ball, and Mr. Chastain presented this special award to Ms. Lydia Jasper, Assistant Curator of the Permanent Collection and 35th Serendipity Guest Curator.

Ms. Jasper shared, "People were interested to know what the exhibition was about, we were able to utilize the Serendipity pamphlets with information (about the hospital and the program) so it was really great for the community that didn't know anything about the State Hospital or the programs it offered to be able to interact in that way. It brought a lot of questions and smiles so it was really great to see the public engaged in a different way.

Ceci (Whitehurst) and Ricky (Shelby) (MSH Art Services) did a really great job of letting people know about the Serendipity Sneak Peek, so we had a lot of visitors that came to the museum for that exhibit and

stayed to visit (other parts of) the museum.

I wasn't expecting an award because it just felt like a natural thing for us to do at the Art Museum. Our mission is to connect the community and the power of art together and it just felt like the natural thing to do with this exhibit. We hope to see how we can connect with the State Hospital in other ways."

The annual meeting continued with committee reports from Sheila Shows for Finance, and Kathy Denton for Projects/ Events and Nominations. Two new board members were elected, Ms. Lynn Dilmore and Mr. Joel Ross.

Mississippi Civil Commitment Process - HB 1640

On Wednesday, July 17, law enforcement officers, chancery/circuit clerks, and community mental health providers gathered at Mississippi State Hospital (MSH) with the goal of learning about the changes to the commitment process and the provision of mental health services in Mississippi that took effect by the passage of HB 1640. Representatives from MSH and the Department of Mental Health (DMH) provided some background on HB 1640 and included a presentation and handouts detailing the

changes to the process, including the areas of Community Mental Health Centers (CMHCs) Reporting, Civil Commitment Flowchart, People Waiting in Jail, Transportation, Time Frame for Hearing, Annual Training, and Guardianship or Conservatorship.

James G. "Bo" Chastain, FACHE, Director of MSH, welcomed guests and stressed how important the partnership is with everyone in the room and how valuable it is to the State of Mississippi. He then provided an overview of the CMHC quarterly reporting process and

requirements. Each CMHC will provide a quarterly report to the board of supervisors in each county of their region and DMH. Reports will include the occupancy percentage reported by the Crisis Stabilization Unit (CSU) in the region, number of individuals held in jail after the commitment process has been initiated and the number of individuals the CMHC provided treatment to while they were in jail, number of pre-affidavit screenings conducted, number of individuals diverted to a lesser restrictive alternate from commitment, number of CSU unit denials and the reason for denial, summary

report of Medicaid claims, and cash balance as of the date of the end of the quarter.

Dr. Tom Recore, Medical Director for DMH, outlined the civil commitment process, walking attendees through a detailed civil commitment flowchart and the technical requirements of holding people in jail. The flowchart contained a detailed guide for each scenario throughout the decision-making process and referenced the sections of Mississippi Code that apply. Before holding someone in jail, the CMHC must explore and exhaust all other options, including CSUs, hospitals, etc. In addition, the chancellor must authorize the jail hold, and the person must be actively violent. A person cannot remain in jail for longer than 24 hours and the CMHC must provide treatment during this timeframe while pending placement at an appropriate facility. An additional 24 hours can be requested by the CMHC and must be approved by the chancellor.

MaCall Chastain, General Counsel for DMH, provided the details of transportation provisions, outlined the time frame for holding a hearing, explained the requirement of DMH

to hold annual training for chancery and circuit clerks (provided opportunities for 2024), and explained guardianship and conservatorships. Transportation provisions allows transportation inside or outside the county for a person to access the treatment they need if they are waiting on a bed related to civil commitment. The state currently has 196 Crisis Stabilization beds throughout the state, if a bed is not available in one region, there is a vacant bed in another region. Chancery clerks and CMHCs can see where CSU beds are available through a bed registry, which is updated daily. Previously, the law required chancellors to hold a hearing within 5-10 days. HB 1640 reduces that timeframe to 3-5 days. An extension of an additional 5 days can be requested. DMH will provide training on civil commitment procedures to chancery and circuit court clerks annually. Any healthcare practitioner who conducts the commitment physical and mental examinations may also, at the time of conducting examinations, provide the certification necessary for establishing a guardianship or conservatorship.

Chastain returned to the podium to discuss the

goals of the Memorandum of Understanding (MOU) between DMH, State Hospitals, and CMHCs/Crisis Stabilization Units (CSUs). These goals include: Provide ready access to the appropriate level of care needed by individuals experiencing a behavioral health crisis. Prevent unnecessary use of jails as holding facilities. Prevent unnecessary admissions to state hospitals. Collaboratively communicate with the Chancery Clerks, Chancery Judges, and Sheriffs to inform them on changes made by the Legislature to the civil commitment laws. Make maximum utilization of each region's CSU bed capacity. Expand State Hospital admission hours to include Saturdays and Sundays to expedite referral of civilly committed individuals served in CSUs who need admission to a State Hospital.

Julie Johnson, Director of MSH Utilization Management, and Lisa Nichols, Director of MSH Admissions, discussed the MSH weekend admissions process, providing step-by-step scenarios for a successful admission.

Guests then had an opportunity to ask the panel questions before enjoying lunch together.






















MSH August Employees of Month
